Dear Friends,

Many thanks to you, our members, friends, and donors, for supporting the Gibson House during fiscal year 2016-2017. This was a period of growth and productivity for the museum, with the introduction of updated programming, new personnel, and initiatives meant to enhance the visitor experience.

Among the year's highlights:

*The museum continued to attract visitors from across the U.S. and around the globe. We were pleased to note a combined increase in visitorship and program attendance of 18 percent over the previous fiscal year, as the museum's active online presence heightens awareness of its unique offerings.

*We remained a significant resource for students and scholars from the Boston area and beyond. In addition to welcoming classes from the Art Guild, the Boston Architectural College, Boston College, Fisher College, Mass College of Art, North Bennett St. School, Simmons College, Suffolk University, and Wentworth Institute of Technology, we hosted interns from Emmanuel and Scripps Colleges as well as the Winterthur Museum, the country's leading institution of American decorative arts.

*We presented entertaining and educational programs on subjects ranging from Victorian mourning customs to reading the interiors in Edith Wharton's House of Mirth, and offered special tours on the museum's paintings, servant life, and family and work, the latter in conjunction with our Boston House Museum Alliance colleagues. We also received a generous gift from Gibson family descendant and museum supporter Rosamond Warren Allen that will enable us to reproduce the blue carpet in the second-floor family room.

*After an extensive search, we hired the talented Meghan Gelardi Holmes to replace retiring curator of twenty-five years, Wendy Swanton. The museum has greatly benefited under Wendy's guidance and is now poised to head in new directions.

Treasurer's Report

The Gibson House ended fiscal year 2016-2017 with a surplus of \$7,493, the highest surplus the museum has seen in nearly a decade. Marketing and community engagement efforts by museum staff and board members continued to pay off, as museum admissions reached an all time high, earning \$18,525. Our strong revenue was due to generous donations from visitors, friends, and board members, which totaled \$32,225 in unrestricted funds. The 2017 annual benefit at the Chilton Club garnered an additional \$37,345 for museum operations and special curatorial projects. Another \$10,000 of income was generated from the sale of letters written by Harriet Beecher Stowe held by the museum. As the letters were not accessioned in the museum's collection, they were sold to the Stowe Center in Connecticut for preservation in their archives.

In fiscal year 2016-2017 the museum only used 20% (\$2,645) of budgeted endowment draw. With the exception of maintenance costs, museum operating expenses were in line with budget forecasts. Maintenance overrun was largely due to a necessary pipe replacement for the fire safety system.

At the conclusion of the fiscal year, the museum had approximately \$410,000 in its endowment. The museum has four endowment accounts, the largest of which is unrestricted with approximately \$364,700. The other three accounts are restricted as funds designated for the Curator, Tour Guides, and Special Projects. The Gibson House Museum ended the year on strong financial footing, and we will continue to work toward increasing its financial stability.

The Gibson House Museum is an authentic Victorian row house located at 137 Beacon Street. Built in 1859, it is one of Back Bay's earliest houses and stands as the historic house museum of the Back Bay. The Museum is open to the public and preserved as a time capsule of the daily life of a well-to-do Back Bay Boston family and its domestic staff. The Gibson House Museum is a National Historic Landmark and listed on the Massachusetts State Register of Historic Places.
